Welcome

Greetings and Happy Holidays,

Wow, what a year this has been! We couldn't have envisioned that during the past year, The Arc would close its offices and facility-based day program, park our buses, postpone the annual dinner, cancel our signature fund raiser, and conduct most meetings virtually, but that is exactly what happened due to the COVID-19 outbreak. When the pandemic began, The Arc immediately responded by limiting services, acquiring personal protective equipment (PPE) and developing a new set of operational guidelines. Since our employment and residential services were deemed essential, we needed to continue providing those services.

We are proud of how our staff members quickly responded to a challenging situation. For example, when the Governor issued the stay-at-home order, I visited all of our residential homes. I was worried about a lack of PPE, how staff were feeling given that an outbreak could potentially occur, and how the people we support were responding to an abrupt change to their daily lives. The response from individuals and staff members was both heartwarming and reassuring. Our staff members shared that they would handle any challenge or outbreak. Their dedication and professionalism were evident. The residents were healthy, safe, and engaged.

The next visit was to our day and employment programs. Responding quickly to the situation, staff members began The Arc's virtual day program. This program was both innovative and welcomed by several individuals who wanted to stay connected. Our employment program continued to support individuals who were working in positions that were considered essential. Imagine, people with disabilities were considered ESSENTIAL EMPLOYEES! I know our founding families would be proud of this significant accomplishment.

While we haven't been able to gather the way we did before to celebrate accomplishments or to fundraise, we are finding new ways to recognize people for helping us bring life to our mission and have had some success with virtual fundraising events.

Like the United States, The Arc elected a new president this year. Corynne Courpas has been connected with The Arc for over 30 years and brings a wealth of knowledge, passion, and leadership to her new role.

As we continue to think about how services may be provided differently in the future, The Arc is sensing a tremendous opportunity to be a leader in developing a new model that is responsive to people's needs, is more individualized, and successfully integrates more people into our wonderful community.

As we look forward to a new year, we are excited about the possibilities. One area of concern is making sure our resources can support our mission. We hope that you will join and support us by making a financial commitment to The Arc.



Virtual Day Program

In response to the pandemic, The Arc Carroll County launched a brand-new service called the Virtual Day Program. Coordinators and direct support professionals partnered together to create a curriculum to be shared via Zoom video chat meetings. The individuals we serve can choose between a wide variety of classes covering topics such as Employment Skills, Cooking Lessons, Self-Advocacy, Music Appreciation, Reading & Vocabulary Skills, and American Sign Language. The World Around Us class is the most popular one. Through this class, the group takes a virtual plane ride each week to different parts of the world to discuss cultures and observe famous landmarks. So far, they have explored Machu Picchu and the Mayan pyramids. This has been the perfect antidote for the cabin fever everyone is feeling these days!

One individual we serve shares:

"I am so excited to see my friends on Zoom, and the teachers who have so many fun ways to help us learn. After every class I tell my mom, 'That was fun.' I know it makes my mom happy because she sings while cleaning the house. I thank everyone at The Arc for your devotion to us during this difficult time."

On a daily basis, individuals grab their sandwiches and tune in for "Lunch with Friends." This provides a great opportunity for socialization, which is much needed during this time of quarantine. Each class is 40 minutes in length, and there are five classes offered Monday through Friday. One of The Arc's values is innovation which this team has fully embraced!
